## 2. Draft Policy on hiring international scholars

Dr. Murphy explained that hiring international tenure track faculty is difficult when they do not have a green card. He explained a "fast track" process to alleviate many of the hurdles involved, which is used by other institutions. He has prepared a draft policy which will be reviewed by the policy committee and Damon Derrick. The deans were in agreement that this policy is needed. The law does not allow for non-tenure track faculty to use this option. This will be discussed further at the January Deans Council.

### 3. Update on SACS Compliance Certification Report

Dr. Guidry gave an update on Class of 2021. Next week the leadership team will attend orientation in New Orleans by SACS VP. Report will be due early spring 2021, we are already working on it, drafting a policy to comply with distance education standard 10.6. Streamlining the process for certifying faculty credentials, new software will be used, information already available in Digital Measures will be transferred to new software.

### 4. Strategic Planning Online Update (SPOL)

Dr Abbott announced that The College of Education will serve as a pilot the online annual faculty evaluations this year within Digital Measures. This will be the same format as paper evaluations but electronic and will include adjuncts, due dates and process are the same. We will be able to pull information directly from Digital Measures in to new SPOL software. This will be available to all other colleges next year. Adjuncts are always the harder to prove they are qualified for the courses they are teaching.

HB2504 are we in compliance? This requires syllabi, faculty CV and student evaluations. We are not in compliance with student evaluations. Dr Guidry is working to get us in compliance and to make the process easier.
