WHAT WE ARE LOOKING AT SOON IS A SURVEY THAT WILL TAKE PLACE AND A SUSS AND REVIEW WHERE WE ARE WITH THAT STRATEGIC PLAN. THE INSTRUMENT WE ARE LOOKING AT IS SPIES. WHICH STANDS FOR STRATEGIC PLANNING IMPLEMENTATION, EXECUTION SURVEY. THAT WILL BE GOING OUT AND WE WANT TO GET A REAL IDEA OF HOW WE ARE DOING? THIS IS HALFWAY THROUGH IN A TIME WHEN WE CAN DO A RESET TO GET THINGS MOVING.

>> ANOTHER THING I TALKED ABOUT WAS TRANSPARENCY, COMMUNICATION , AND LASER FOCUS. SOME OF THE THINGS I TALKED ABOUT ARE HITTING DIRECTLY ON THE IDEA OF STUDENT SUCCESS. AS FAR AS TRANSPARENCY AS WELL. I NEED TO GET WITH THE FINANCIAL ADMINISTRATION TEAM. THEY BEEN WORKING CLOSELY TO PUT TOGETHER A PRESENTATION SO THAT IT WILL BE BROUGHT TO ALL OF THE COLLEGES. WE WILL BE SITTING DOWN AND GOING THROUGH THAT BUDGET VERY CLEARLY AND CONCISELY SO THAT EVERYONE ACROSS CAMPUS HAS AN UNDERSTANDING OF THE BUDGET, WHERE IT COMES FROM, AND WHERE IT GOES. IN ADDITION TO THAT WE HAVE BEEN WORKING ON A BUDGET PRIORITY PROCESS THAT YOU WILL SEE SOON IN ANTICIPATION OF THE NEXT ACADEMIC YEAR. WE REALLY HAVE TO PUT THE PENCIL TO THE PAPER. ALL OF THIS WILL BE OPEN AND TRANSPARENT. THERE WILL BE A WEBSITE WHERE YOU WILL BE ABLE TO SEE THE REQUESTS AND PRIORITIES OF

ALL DIFFERENT UNITS ACROSS CAMPUS THOSE ARE A FEW OF THE THINGS IN THE LAST 45 DAYS THAT YOU MAY WANT TO HEAR ABOUT. I AM OPEN TO

QUESTIONS. ANOTHER THING I WOULD LIKE TO DO IS GIVE YOU A FEW KEY DATES THAT ARE IMPORTANT FOR THE REST OF THIS TERM. SINCE THE BOARD WILL NOT BE MEETING AGAIN UNTIL JANUARY. - >> I WILL TRY TO DO MY BEST TO FOLLOW UP AFTER DR. SCOTT GORDON. LIKE WITH THE CONCERT THE HEADLINER HAS ALREADY PLAYED.
- >> I THINK YOU FOR INVITING THE FACULTY SENATE TO GIVE A SHORT PRESENTATION . I AM TO START OUT BY INTRODUCING MYSELF. THE FIRST TIME I'VE BEEN HERE TO PRESENT. I HAVE BEEN HERE FOR 14 YEARS. I'M AN ASSOCIATE PROFESSOR OF HISTORY, I WILL BE THE CHAIR NEXT YEAR IS THE CURRENT CHAIR WILL BE TRAVELING. I WANT TO START OFF BY WELCOMING DR. SCOTT GORDON. CONGRATULATIONS ON BEING NAMED THE NEW PRESIDENTS . HIS TRACK RECORD IS IMPRESSIVE. WHAT I FIND MOST IMPRESSIVE IS THAT HE IS A FIRST GENERATION COLLEGE STUDENT. SFA SERVES A LARGE PROPORTION OF

FIRST-GENERATION COLLEGE STUDENTS. AND I THINK IT'S IMPORTANT THAT HE UNDERSTANDS THAT AND EVERYONE'S EXCITED ABOUT MOVING FORWARD UNDER HIS LEADERSHIP. I HAVE NOT HEARD A SINGLE QUESTION ARE NEGATIVE THINGS SINCE THE INTRODUCTION. THAT'S A VERY IMPRESSIVE START TO THE ADMINISTRATION. HOPEFULLY CONTINUES ON. I WANT TO TOUCH ON A FEW THINGS THAT THE FACULTY SENATE WANTS TO BRING TO YOUR ATTENTION. I UNDERSTAND THAT YOU HAVE A LIST OF FACULTY ACCOMPLISHMENTS AND ACHIEVEMENTS. I URGE YOU TO LOOK OVER THOSE ITEMS TO SEE WHAT FACULTY MEMBERS ARE UP TO ON A REGULAR BASIS. THIS IS A YEAR AROUND SUSTAINED EFFORT. EVEN IN THE SUMMER WHEN FACULTY ARE NOT UNDER CONTRACT THEY CONTINUE TO WORK ON BEHALF OF THEIR STUDENTS AND THE INSTITUTION. IF YOU HAVE A CHANCE GO OVER THOSE LISTS AND ACCOMPLISHMENTS. THE FACULTY SENATE HAS DONE IN TWO MAJOR THINGS THIS YEAR. AN AMENDMENT TO THE CONSTITUTION THAT I WANT TO MAKE YOU AWARE OF . THE FACULTY SENATE CONSTITUTION WAS AMENDED IN TWO WAYS. SIMPLE WORDING CHANGE TO CHANGE ADJUNCT TO NONTENURE TRACK FACULTY.

THE SECOND WAS A LITTLE MORE OF A SUBSTANCE A CHANGE. THERE ARE CURRENTLY TWO TEN-YEAR NON-TRACK FACULTY MEMBERS THAT HAVE BEEN ELECTED. THERE WAS CONSTANT TURNOVER. THE AMENDMENT WAS TO PUT THEM INTO THREE-YEAR TERMS. SO THEY WOULD HAVE MORE STABILITY IN THEIR REPRESENTATION. IT WOULD BE MORE OF A VOICE THROUGH US TO YOU. THE LAST THING I WANT TO TOUCH ON IS A FACULTY IN SENATE RESOLUTION REGARDING FUTURE PRESIDENTIAL SEARCHES. I UNDERSTAND THAT THE TEXT OF THIS IS ON THE WEBSITE AND HAS BEEN DISTRIBUTED TO THE BOARD OF REGENTS MEMBERS. I WANT TO MAKE IT CLEAR BEFORE WE INTRODUCE THIS AND DISCUSS IT IS NOT INTENDED TO RAISE COLLECTIONS QUESTIONS ABOUT THE SELECTION OF DR. SCOTT GORDON. IS A PERFECT CANDIDATE IN EVERY WAY. THAT IS A FIRST WHEREAS. WE HIRED AN EXCELLENT CANDIDATE. NOT INTENDED TO BE ANY CRITICISM OF THE OUTCOME OF THE SEARCH. WE APPRECIATE ASPECTS OF THE SEARCH THAT DID INCLUDE FACULTY AND COMMUNITY MEMBERS. THE SOUNDING SESSIONS WERE HELD IN MARCH. AND THEY WERE ASKED WHAT THEY WANTED TO SEE FROM A FUTURE PRESIDENT. WHERE THE FACULTY WOULD LIKE TO START A CONVERSATION IS WHEN IT CAME TO THE PRESIDENTIAL SCREENING COMMITTEE THERE WAS ONLY A SINGLE FACULTY MEMBER ON THAT COMMITTEE. I DO NOT QUESTION WHY THAT DECISION WAS MADE OR THE GOOD FAITH EFFORTS OF THE PRESIDENTIAL SEARCH. THERE IS AN ADVANTAGE TO HAVING A SMALL COMMITTEE. I'VE SEEN OTHER UNIVERSITIES THAT HAVE OVER 20 PEOPLE. THE FACULTY SAID THAT THEY LOOKED AT THE PREVIOUS DECADE OF SEARCHES AND FOUND THAT THEY

AVERAGE REPRESENTATION WAS 3-5 FACULTY MEMBERS. VERSUS JUST ONE. SO THE RESOLUTION IS REQUESTING. NOT DEMANDING. JUST REQUEST THAT THERE NEXT TIME THERE IS A SEARCH THAT IS HOPEFULLY IN THE FAR FUTURE THAT THERE BE ADDITIONAL FACULTY MEMBERS ADDED TO THAT SCREENING COMMITTEE SO THAT WE COULD HAVE A LITTLE MORE BOYS IN THE PROCESS . SOME OF YOU MAY BE ASKING WHY NOW? WHY RAISE THIS QUESTION NOW THEN WHEN THERE IS A FUTURE SEARCH. IF I COULD STEP INTO MY HISTORICAL SHOES. IF WE LOOK AT HISTORY AND BUILD A HYPOTHETICAL 20 YEARS TIME. THAT DR. GORDON WANTS TO SPEND SOME TIME FISHING. AND WE HAVE A NEW PRESIDENTIAL SEARCH. I'VE LOOKED AT THE HISTORY OF THE UNIVERSITY. BY THAT TIME NONE OF THE BOARD OF REGENTS WOULD HAVE BEEN THE SAME. NONE OF THE SENATORS WOULD BE THE SAME. IT IS A REASONABLE QUESTION WHEN THERE IS A SEARCH LIKE THAT. IF NO ONE RAISE THE QUESTION LAST TIME R STARTED THE QUESTION THEN IS IT MORE DIFFICULT TO START THE CONVERSATION THE NEXT TIME. IS JUST A WAY FOR US TO SAY NEXT TIME YOU CAN SAY THIS IS BEEN RAISED BEFORE AFTER THE LAST PRESIDENTIAL SEARCH. THERE IS A HISTORY TO

IT. THAT WAS THE THINKING BEHIND THE RESOLUTION AND DISCUSSION ON THAT. I AM COMPLETELY OPEN TO ANY QUESTIONS THEY HAVE ON THE.

>> THANK YOU. VERY MUCH. [APPLAUSE]

>>> THE NEXT REPORT COMES FROM STUDENT GOVERNMENT ASSOCIATION .

>> HELLO EVERYONE HOW ARE YOU DOING. IT'S REALLY GOOD TO HEAR AFTER HOMECOMING THAT EVERYONE IS DOING WELL. I WOULD LIKE TO WELCOME DR. GORDON. WE HOPE YOU HAD A GOOD TIME AT HOMECOMING. I'M GLAD THAT YOUR FIRST 45 DAYS INCLUDED SCHOOL SPIRIT. JUST TO GET INTO THE REPORTS. I AM THE STUDENT BODY PRESIDENT. AND IT'S FUN SOMETIMES TO HUNT THROUGH THOSE OLD MINUTES TO FIND THOSE ANSWERS. THE BOARD ASSIGNED ME TO RENT EVENT THE BOARD ROOM, ADD TECHNOLOGY, TO INCREASE THE TABLE. WE NEEDED TO STRETCH THE TABLE AND ADD THE STAINED GLASS COLLECTION IN THE BACK ROOM THAT WAS LUCKILY SAVED BY A GROUP OF PROFESSORS THAT KEPT IT FOR US. THIS WAS A GREAT PLACE TO STORE IT TO DISPLAY IT. THERE WERE A LOT OF HER RESEARCH PROJECTS. IT WAS A VACUUM GUILTY FACULTY SURVEY THAT WAS DONE EARLY ON. HOW IT COMPARED TO OTHER TEXAS UNIVERSITIES. AND WHEN WE NUMBER THEM I WAS ABLE TO LOOK BACK TO SEE THAT I HAVE ATTENDED 119 BOARD MEETING THAT MAKES ME REALLY TIRED I HAVE WORKED WITH 10 BOARD CHAIRS, AND 29 DIFFERENT BOARD REGIONS THERE IS NOBODY AT THIS TABLE THAT WAS HERE WHEN I STARTED . I TOLD THEM THAT I HAVE SENIORITY. IN THIS ROOM THERE ARE MANY PEOPLE THAT HAVE SENIORITY OVER ME. AND I AM PROUD TO SAY THAT IT IS NOW A PLACE OF SOLID RECORDS AND EFFICIENT PROCESSES. AND A REALLY GOOD RELATIONSHIP WITH FACULTY AND STAFF ON THIS CAMPUS. PEOPLE ON THIS CAMPUS WORK WELL TOGETHER.

EVERYONE HAS THE BEST INTEREST OF THE UNIVERSITY AT HEART AND THEY WANT TO BE A MEMBER OF THE TEAM. SO WHEN HE ASKED ME THAT FUNNY QUESTION THAT WE LAUGHED ABOUT. WHY IN THE WORLD DID YOU WANT THIS JOB? MY ANSWER

- IS THAT I REALLY HAVE A DEEP RESPECT AND ADMIRATION AND APPRECIATION FOR THE WORK OF THE GOVERNING BOARD OF THE UNIVERSITY. AND I WANT TO CONTRIBUTE TO THAT GOOD WORK. I HOPE THAT IN SOME SMALL WAY I HAVE BEEN ABLE TO DO THAT. THE BEST THING I CAN SAY IS THAT THE TAKE AWAY IS GREAT MEMORIES , WONDERFUL FRIENDSHIPS AND A REAL INTEREST. I'M EXCITED TO SEE WHAT WE DO NEXT. [APPLAUSE]
- >> WE ARE VERY SAD TO SEE YOU GO. SHE WILL BE WITH US THROUGHOUT THE SEMESTER, SO YOU HAVE PLENTY OF TIME TO COME AND GIVE YOU OUR WELL WISHES.
- >> WE HOPE YOU ENJOY MANY MORE ADVENTURES AHEAD OF YOU. WE WISH YOU WELL. WE HAVE A COUPLE OF SPECIAL THINGS FOR YOU. JUDY LIKES TO GIVE EVERYONE ELSE AND ASK.
- >> I ALWAYS SAY WHAT ARE THEY GOING TO DO WITH THAT? [APPLAUSE]. [APPLAUSE] WITH THAT THIS MEETING IS ADJOURNED.
