- 1. Chairman Vincent called the meeting to order at 3:10 p.m.
- 2. After the roll call, Chairman Vincent welcomed the new Senators to the Senate.

Reports of Officers:

Chairman Vincent reviewed the Senate accomplishments of the past year, namely: (a) work on the conference committee to devise a new system of departmental administration, (b) approval of policy and procedures for evaluation of Deans and the Director of Libraries, (c) approval of recommendations for research grants and eligibility for teaching, (d) approval of promotion policy, (e) approval of a study on university committees, (f) approval of a study on salary equity, and (g) approval of new Standing Rules for the Senate.

He reported work in progress on: (a) Tenure Policy, (b) evaluation of the graduate program, (c) revision of the <u>Faculty Handbook</u>, (d) study of the attrition problem, and (e) study of possible withdrawal from Social Security system.

Chairman Vincent reported that the Senate established a policy this year of Committees' submitting a progress report to the Chairman at the end of the year and of committee appointments being continuous throughout a Senator's term in order to aid in continuity between Senates. The policy makes the Senate Chairman accountable for any changes in committee assignments.

Some of the issues to be passed on to the new Senate are: (a) grade inflation, (b) Constitutional revision, and (c) study of structure and function of Academic Councils.
