- * An Institutional Research person has been hired to compile the <u>University Facts Book</u> and to assist in the evaluation of the institutional effectiveness.

Highlights of Mr. Click's report

- The University will soon have a separate Academic and Administration computing system.
- The University will, over the next two years, investigate software to be used for administrative services.
- It will take 18 months to 3 years to convert all needed administrative software.
- The new academic computing system is a small VAX system. (Should be in place by June.)
- The University will become a member of the Texas University Computing System.
- Plans for the Fiber Optic Ethernet Backbone wiring system were discussed.

Chairman Lackey thanked Mr. Click for his informative report.

Further, the presentation of the material shall be considered a first reading and action on the report/resolution shall be taken at the next meeting.

Motion passed to table the previous motion.
