## SECTION 1 INTRODUCTION

#### 1.1 SCOPE OF PROPOSAL

Stephen F. Austin State University, hereafter referred to as "SFA" or "the University", is seeking proposals to award a contract to a vendor or vendors for the exclusive right to supply Logo/Brand Name Athletic Apparel, Uniforms, Equipment and Accessory Products to the SFA Intercollegiate Athletics Department.

#### 1.2 CONTRACT TERM

The term of this contract shall be a term of five (5) years beginning September 1, 2018 through August 31, 2023, with the option to renew for five (5) additional one year periods upon mutual agreement of both parties.

#### 1.3 SFA INFORMATION

Since its founding in 1923, Stephen F. Austin State University has established a reputation of providing a traditional, residential college experience serving approximately 2,300 part-time students and more than 11,900 full-time students, with approximately 3,000-3,500 making SFA residence halls their home-away-from-home. To meet the needs of these students, SFA employs approximately 1,400 full and part-time faculty and staff. SFA is an institution of higher education operated as an agency of the State of Texas. A 9-member Board of Regents is appointed by the Governor of Texas, each serving staggered 6-year terms.

#### 1.5 OPEN RECORDS

The parties understand the information exchanged in the negotiation process is confidential to the fullest extent permitted by law, and neither party will disclose such information to anyone other than representatives of the negotiating parties except as required by Texas law. Final awards and contracts, after all negotiations are completed, may be subject to open records. Additionally, state law requires each contract for the purchase of goods or services to be posted on the University's website. By entering into a contract with the university, the firm acknowledges and

accepts the university will comply with all applicable laws regarding the public posting of contracts.

#### 1.6 U.S. DEPARTMENT OF HOMELAND SECURITY'S E-VERIFY SYSTEM

By entering into this Contract, the Contractor certifies and ensures that it utilizes and will continue to utilize, for the term of this Contract, the U.S. Department of Homeland Security's E-Verify system to determine the eligibility of:

- 1. All persons employed to perform duties within Texas, during the term of the Contract; and
- 2. All persons (including subcontractors) assigned by the Contractor to perform work pursuant to the Contract, within the United States of America.

The Contractor shall provide, upon request of SFA, an electronic or hardcopy screenshot of the confirmation or tentative non-confirmation screen containing the E-Verify case verification number for attachment to the Form I-9 for the three most recent hires that match the criteria above, by the Contractor, and Contractor's subcontractors, as proof that this provision is being followed.

If this certification is falsely made, the Contract may be immediately terminated, at the discretion of SFA and at no fault to SFA, with no prior notification. The Contractor shall also be responsible for the costs of any re-solicitation that SFA must undertake to replace the terminated Contract.

#### 1.7 TITLE IX

Stephen F. Austin State University strictly adheres to Title IX of the Education Amendments of 1972, the federal Campus Sexual Violence Elimination Act: United States Department of Education regulations and directives; and the university's sexual harassment policy and procedures ("Regulations"). Specifically, the Regulations apply to all students, employees, visitors, and other third parties on Stephen F. Austin State University-controlled property, including institutions and entities with whom Stephen F. Austin State University places its students. Further, such Regulations prohibit unequal treatment on the basis of sex as well as sexual harassment and sexual misconduct. As a condition of employment, enrollment, doing business, or being permitted on the campus, the above-mentioned individuals, organizations, and entities must agree to: 1) Report immediately to the Title IX coordinator any and all claims of sex discrimination or sexual misconduct; 2) Cooperate with Stephen F. Austin State University's Title IX investigation; and, 3) Cooperate fully with all sanctions that Stephen F. Austin State University may impose against such individual, organization, or entity, who is found to have violated the Regulations. If the individual, organization, or entity fails to adhere to any of the aforementioned requirements, Stephen F. Austin State University reserves the right to take appropriate action, including but not necessarily limited to, immediate removal from campus; discipline of employees and students (including termination of employment and/or expulsion from school); and termination of business or contractual relationships.

#### 1.8 ISRAEL NON-BOYCOTT VERIFICATION

Pursuant to Section 2270.002, *Texas Government Code*, Contracting Party hereby represents, verifies, and warrants that it does not boycott Israel and will not boycott Israel during the term of the Agreement, as that term is defined by Section 808.001(1), *Texas Government Code*.

#### 1.9 CONTRACTS WITH FOREIGN TERRORIST ORGANIZATIONS PROHIBITED

Pursuant to Section 2252.152, Texas Government Code, and to the extent applicable, Contracting Party hereby represents, verifies, and warrants that it does not do business with Iran,

Sudan, or any foreign terrorist organization identified on a list prepared and maintained under Section 806.051, 807.051, or 2252.153, Texas Government Code.

#### 1.10 HUB SUBCONTRACTING PLAN

All proposals that are \$100,000 or greater in value must contain a properly completed HUB Subcontracting Plan. Each respondent is required to make a good faith effort to subcontract with historically underutilized businesses and shall submit a HUB Subcontracting Plan using the HUB Subcontracting Plan documents provided in Exhibit D.

Stephen F. Austin State University is committed to making a good faith effort to increase business with historically underutilized businesses (HUBs) by contracting with HUBs either directly or indirectly through subcontracting opportunities. Respondents are encouraged to actively seek to subcontract or partner with HUBs in an effort to create an environment that actively acknowledges and values diversity.

The University has determined that subcontracting opportunities are probable under this contract.

The University's HUB goal for this procurement is: 20.8% for Commodities

Each HUB subcontracting plan will be evaluated independently of the response. If the HSP does not reflect a good faith effort to subcontract with HUBs, the entire response will be disqualified.

## SECTION 2 STATEMENT OF WORK

#### 2.1 SCOPE OF WORK

Stephen F. Austin State University hereafter referred to as "SFA" or "the University" will be seeking to award a contract to a vendor or vendors for the exclusive right to supply Logo/Brand name Athletic Apparel, Uniforms, Equipment and Accessory Products to the SFA intercollegiate Athletics Department.

#### A. Products:

Examples of equipment, uniform, athletic apparel and accessory products are listed belowthis list may not be exhaustive:

- Team uniforms
- Practice gear-shorts, t-shirts
- Training and Competition shoes-cleats, turf, running
- Team travel/warm up suits
- Sweat pants & sweat shirts
- Coaching gear-shorts, pants, polo shirts
- Coaching shoes
- Travel bags
- Miscellaneous-socks, etc
- Equipment

#### B. Sports:

- Men & Women's Basketball
- Baseball
- Softball
- Men & Women's Track & Field
- Soccer

- Football
- Women's Tennis
- Volleyball
- Men & Women's Golf
- Women's Bowling

The University reserves the right to incorporate other sports.

Products will be for teams, coaches and athletic department staff for practice, competition and team travel.

All equipment/apparel/accessory products provided under this proposal must be new. Items which are used, demonstrators, obsolete, seconds or which have been discontinued are unacceptable.

#### 2.2 PRICING

Respondent shall provide pricing and all fees, product line discounts, costs or expenses to be charged for goods and services provided. Pricing shall be all-inclusive. Reference Exhibit C.

#### 2.3 VENDOR REQUIREMENTS

The University seeks a vendor to provide athletic apparel, equipment, and accessories for all of its Athletic programs and any athletic programs that may emerge during the term of the contract. Respondent is to provide the University with detailed responses to the following:

2.3.1 Apparel to outfit athletic coaches, players, and staff members. A proposal may include a specific dollar cap and catalogs to determine the offer or, preferably, a team-by team specific apparel offer to specifically address the needs for our sports programs. .

Describe how your firm plans to provide exclusive uniform and apparel supplies and equipment for each sponsored intercollegiate athletics program, support personnel and support programs. Please provide values for product allowances, coaches' allowances, staff allowances and additional products allowances offered and confirm how allowance pricing will be valued. Include information on how apparel items would be priced, e.g. a price list of typical apparel/uniform items or a description of the discount from list price. Provide a list of approved team dealers for our region.

In addition, please provide information relating firm's products and describe how the University will obtain products on a routine and emergency basis. Also, please include information relating to delivery schedules for products, return policies, warranties, and information on any additional costs (including pricing for screen-printing and embroidery if necessary).

2.3.2 Provide information as to how you will establish marketing and advertising partnership through various mediums such as, but not limited to, facility signage, posters, official game day programs, web page advertising, schedule cards, etc.

Describe the firm's marketing and licensing strategies and requirements for authentic equipment and apparel.

- 2.3.3 Incentives paid to SFA athletics for championships won by the outfitted teams, post-season tournament appearances, etc.
- 2.3.4 Provide any other considerations the vendor believes would be beneficial in gaining "official" status with SFA Athletics.

- 2.3.5 Provide sufficient information regarding each of the items below so the University can thoroughly evaluate your firm's qualifications and proposal for our search process. You may include support literature and attachments to the summaries requested below:
  - a. Describe the vendor's expertise and experience with programs of this type.
  - b. Include details of the vendor's background and its size and resources as well as details of experience relevant to the proposed project. Include individuals assigned to work with the University including their contract information, role, and a description of their experience. Please include how long your firm has been in business and include any mergers or acquisitions.
  - c. The University requires assurance that the offered products function properly. Vendors shall provide a listing of at least five (5) references from current or former clients at institutions similar to SFA. Please include name, title and telephone number of a contact person at each institution.
- 2.3.6 The University may choose to use other vendors' products when vendor is unable to provide a necessary product or good for a particular sport or event.

3.2.3 All U.S. Mail addressed to any component of SFA is delivered to a central mail room and redistributed by SFA personnel to the addressee's on-campus post office box. Consequently,

- there is a possibility of delay between receipt of mail at the central mail room and receipt in the Purchasing and Inventory Department. Proposals must be in the office of the Purchasing and Inventory Department by the time set for RFP closing in order to be considered, and receipt by SFA at the central mail room will not be deemed sufficient.
- 3.2.4 Proposals will be publicly opened Wednesday, October 11, 2017, at 8:00 am in the office of the Procurement and Property Services, 2124 Wilson Drive. Only the names of the Respondents will be read aloud.
- 3.2.5 Proposals received after the time for closing will be returned to Respondent unopened regardless of the circumstance. It is the responsibility of the Respondent to get the proposals delivered in a timely manner regardless of delivery method or circumstances.
- 3.2.6 Faxed or electronically mailed proposals will not be accepted.
- 3.2.7 Proposals may be withdrawn at any time prior to the time and date set for proposal closing.
- 3.2.8 Stephen F. Austin State University reserves the right to accept or reject any or all proposals and to waive irregularities or technicalities provided such waiver does not substantially change the offer or provide a competitive advantage to any Respondent in the judgment of Stephen F. Austin State University.

#### 3.3 SUBMITTAL INSTRUCTIONS

- 3.3.1 All proposals must be submitted in the format prescribed in Section 3.6.
- 3.3.2 Each Respondent must submit at least <u>one original proposal</u> with original signatures on the Execution of Offer and Form of Proposal and five (5) complete copies.
- 3.3.3 All proposals must be complete and convey all of the information requested to be considered responsive. If the proposal fails to conform to the essential requirements of the RFP, SFA alone will determine whether the variance is significant enough to consider the proposal susceptible to being made acceptable and therefore a candidate for further consideration, or not susceptible to being made acceptable and therefore not considered for award.
- 3.3.4 Each respondent, by submitting a proposal, represents that the respondent has read and completely understands the request for proposal documents and agrees to abide by the terms of this RFP and any resulting agreement. Failure of the selected contractor to fulfill the provisions of this request for proposal shall in no way relieve the obligation of the Contractor to furnish all services necessary to carry out the provisions of the agreement.
- 3.3.5 Proposals shall be signed by a legally authorized representative of the Respondent. Unsigned proposals will be rejected as a material failure.

#### 3.4 ACCEPTANCE AND FORMATION OF AGREEMENT

- 3.4.1 No recommendation for award will be made until Stephen F. Austin State University is fully satisfied that the Respondent is professionally competent and properly equipped to render the specified legacy displays.
- 3.4.2 The University reserves the right to further negotiate, after proposals are opened, with any Respondent that submits a proposal. SFA may award a contract(s) based on initial proposals received without any discussion of such proposals. Therefore, each proposal should be submitted on the most favorable and complete price and terms possible.

3.4.3 SFA reserves the right to enter into an agreement not based only on the cost to the University, but which, in the sole opinion of SFA, is deemed to represent the best value to SFA.

#### 3.5 EVALUATION CRITERIA

- 3.5.1 Award will be based on a comprehensive review and analysis based on a weighted value of averaged evaluation scores and negotiation of the proposal that best meets the needs of the University. Submission of a proposal represents concurrence with this method of evaluation and award. Furthermore, Respondents will not, under any circumstances, dispute any award made using this method.
- 3.5.2 Evaluation of the proposals will be performed by an evaluation committee representing Stephen F. Austin State University. Proposals will be evaluated using the following criteria, which are listed below in no particular order. Stephen F. Austin State University reserves the right to award an agreement not based only on the cost to the University, but on the criteria that best meet the University's requirements and goals. The University shall be the sole judge of determining which proposal represents the best value to the University.

#### 3.5.3 Criteria

- a. 20% Cost Structure;
- b. 20%- Overall Quality of Product and Availability
- c. 20%-Product allowances and other promotional product credits
- d. 10% Incentive plan for coaches and teams wining conference or national championships or awards
- e. 20% Experience with SFA
- f. 10%-Vendor expertise and qualifications including references

#### 3.6 PROPOSAL FORMAT

- 3.6.1 Proposals shall be prepared in a straightforward and concise manner, identifying clearly and concisely any deviations, enhancements, and other differences that exist between the RFP and the respondent's proposed services. Emphasis should be placed on responsiveness to the RFP requirements, completeness and clarity of content and conformance to the RFP instructions.

  Respondents shall organize their proposal in a point-by-point format according to Section 3.6.2. Failure to follow point-by-point presentation could be grounds for disqualification.
