A. HOUSE AND LAND SALE

06-08

Upon motion by Regent Green, seconded by Regent Boyer, with all members voting aye, it was ordered that the university be authorized to sell the house and two acres of land from the 152 acre tract in the O.W. Randall survey, Abstract 462, otherwise know as 1256 FM 2664, at a price of \$140,000 with the proceeds to be used towards the original purchase cost of the land, improvements at the Walter C. Todd Beef Farm, or purchase of additional land for the farm.

B. RECREATIONAL SPORTS FEE

06-09

Upon motion by Regent Green, seconded by Regent Ertz, with all members voting aye, it was ordered that approval be given to a recreational sports fee of \$120 per student who enrolls for 7 or more semester credit hours during fall and spring semesters and \$50 per student who enrolls for 6 or less semester credit hours. It is further approved that a student who enrolls for 6 or more semester credit hours during a summer session be assessed a recreational sports fee of \$60 and a student who enrolls for less than 6 hours during a summer session be assessed a fee of \$25.

C. REPORT ON INFORMATION TECHNOLOGY

The university administration will hold a planning retreat on December 13, 2005 to develop a SFA Strategic Technology Plan. Key recommendations from that summit will be brought to a future board committee meeting.

At 9:25 a.m. the board moved into executive session to conduct interviews with candidates for Vice President for Finance and Administration.
