1. **W/WH Grades**

Dr Murphy has received word from several faculty members that students are dealing with emotional issues, in light of Covid and online classes. He asked if we should be more lenient with the W/WH policy, perhaps extending the time students can make up the work by an additional year. Dr. Beverly said this would put a huge burden on faculty and Dr. Guidry stated we have the most liberal WH policy in the state and would not advocate to be more lenient. It was agreed the deans would discuss with their unit heads and we would discuss the issue at dean's council on December 2.

Dr. Bullard said the probation and suspension policy has been put on hold because of Covid, students are asking if this is being extended or restored, we will get further information from Lynda Langham and discuss at deans council.

The Open SFA Task Force document dated June 18, will be reviewed for spring semester. Dr. Williams will send the document to the deans for their review.

Andrew Lannen had questions about timeline as faculty senate will not meet until February, Dr. Bullard said there is no strict deadline, so there will be time for discussion. The plan is for any proposed changes to go into effect fall 2022, with input from the new provost.

5. **Course Evaluations/Promotion & Tenure**

Dr. Lannen brought concerns from faculty senate regarding items added to course evaluations concerning the 8-week courses, as requested by Dr. Gordon. The questions were vetted by chairs and deans. It was agreed these questions would not be used in consideration of tenure and promotion for faculty. The course end evaluations were used because they have a better return rate. The Graduate school sent out a separate survey.

6. **Potential Telecommuting after Commencement**

This was mentioned in Cabinet meeting yesterday and an email will be sent out to the campus. Due to a resurgence of Covid cases, telecommuting is encouraged. There was also a question on whether we will have a face to face commencement.

7. **Any Other Business**
