

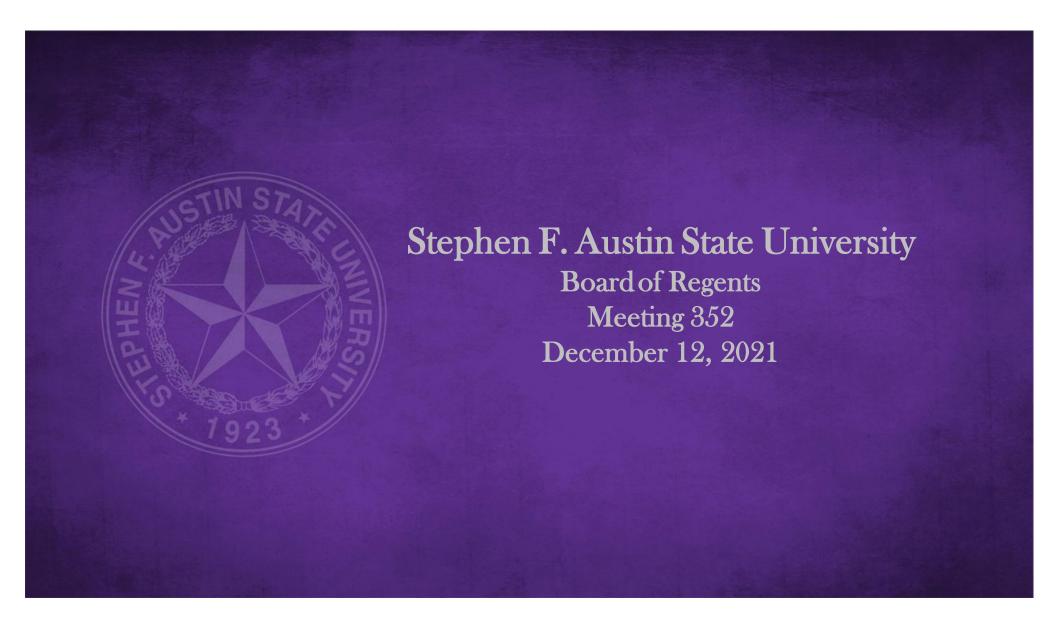

As required by Texas Government Code, Section 2101.011, Stephen F. Austin submitted the August 31, 2021, Annual Financial Report to the Office of the Governor, Comptroller of Public Accounts, Legislative Budget Board, Legislative Reference Library, and the Texas State Auditor's Office. Explanation:

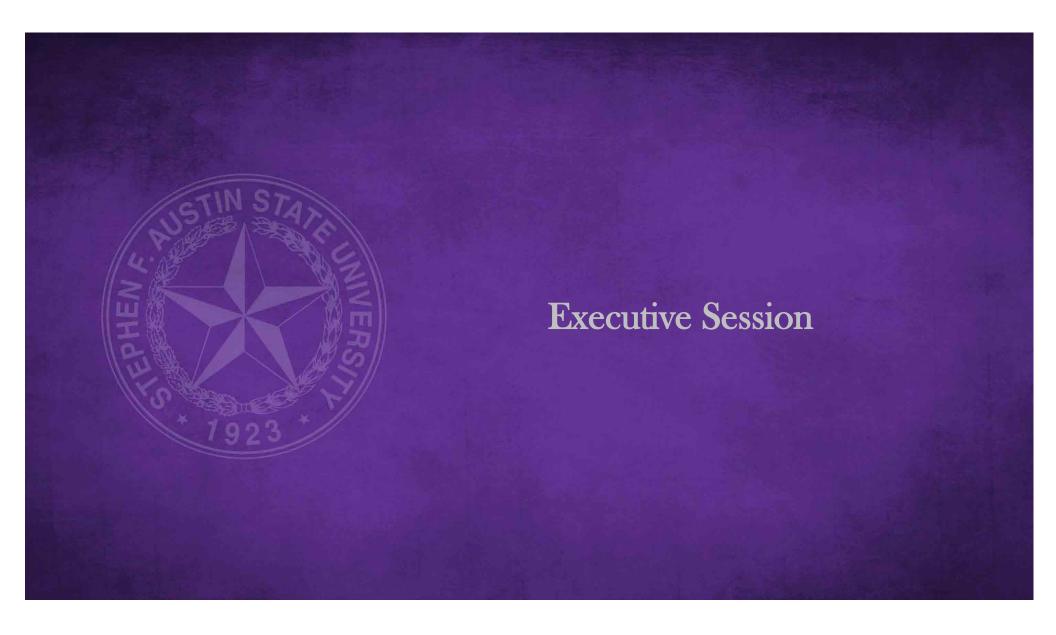
