- o Approval of Spring 2020 Summary Notes: The Summary notes were approved as presented.
- o Dr. Judy Abbott, Dean
 - SFA, Educator Preparation, and PCOE updates
 - New Leadership to date includes President, Dr. Scott Gordon, who came from Eastern Washington.
 - SFA is experiencing an austerity budget due to COVID-19.
 - Changes to date include course schedule and delivery modalities
 - We have eight-week models for scheduled classes in addition to our 16-week courses.
 - o For Fall 2020 SFA will pivot to all remote learning on November 30th.
 - SFA will experience significant personnel changes with a voluntary separation incentive program (VSIP) that was recently offered 110 applied for the VSIP including:
 - o Provost & Vice President for Academic Affairs
 - Vice president for Undergraduate Affairs
 - Dean of Research & Graduate Studies
 - Dean of Fine Arts
 - o Dean of Liberal & Applied Arts
 - Controller
 - Registrar
 - The following new terminal degree has been approved for offering: EdD in Curriculum and Instruction
 - The EdD has been approved to be delivered online.
 - The M.Ed. has been approved to offer the following new concentration: Athletic Director.
- Ronda McClain, Program Support Coordinator/Instructor, reported for Dr. Brandon Fox, Education Studies Department Chair

- Education Studies Updates and Information
 - Education Studies is a newly formed department.
 - All Classes are virtual, hybrid in zoom and online at this time.
 - Due to COVID-19, the Early Childhood Lab is creating a program analysis to create new directions and ways to move forward. We are functioning and taking care of children during this pandemic. The difference is the number of TA's that help with that.
 - Charter school has no visitors at this time but they do have some classes going on online/virtual and face to face but limiting contact.
 - Thanks to all the ISD partners.
 - We appreciate the opportunity to collaborate with each of you.
 - Currently some teacher candidates are face to face, the majority are learning virtually and zooming into classes that are face to face.
 - Working are closely with Nacogdoches, Lufkin, and Cleveland and exploring all platforms within departments as well as ISD's.

Advisory Council Training

- o Review EPP Advisory Council purpose
 - To assure that appropriate stakeholders including school and community partners are involved in program evaluation, improvement, and identification of models of excellence.
- o TEA Information and Flexibility due to COVID-19
 - As a Result of Governor's Waivers due to COVID-19, in the 2020-2021 school year, there are approximately 14,000 teachers who had not completed testing requirements prior to the issuance of their certification.
 - One-year Waiver Probationary Certificates were issued to EPP finishers who were unable to complete testing requirements
 - TX: 7,312 certificates issued to 5,918 Individuals
 - SFASU recommended 95
 - Intern Waiver Certificates issued to candidates enrolled in an EPP who were unable to complete testing requirements
 - TX: 11,470 certificates issued to 8,118 Individuals
 - SFASU recommended 1
- First year teachers (completing requirements in 2019-2020) were issued certification based on the following:
 - Spring 2020 –A TEA waiver allowed for as few as 35 days of clinical teaching
 - TEA normally requires 70 SFA normally requires 75
- First year teachers (completing requirements in 2020-2021) will be issued certification based on the following:
 - Fall 2020 as few as 30 hours of observations prior to clinical teaching and as few as 56 days of clinical teaching
 - TEA is allowing all observations to be electronic/video
 - Some candidates have only had virtual experiences with clinical teaching

- Science of Teaching Reading--Legislature mandates that all teachers pursuing a certification that includes grades prekindergarten through grade 6 demonstrate proficiency in the science of teaching reading.
- December 31, 2020
 - Last date for candidates to receive their certification in the following areas without needing the Science of Teaching Reading (STR) exam
 - Core Subjects: Early Childhood Grades 6
 - Core Subjects: Grades 4-8
 - English Language Arts and Reading: Grades 4-8
 - ELAR/SST: Grades 4-8
- Pearson's Steps to Address Testing Challenges
 - Pearson owned testing centers have reopened
 - Addition of new partner centers
 - Extension of hours/days of operations at centers
 - Social distancing requirements are factored into capacity
