- 5. 2016 edTPA: Middle Childhood Mathematics;
- 6. 2017 edTPA: Middle Childhood Science;
- 7. 2018 edTPA: Middle Childhood English Language Arts; and
- 8. 2019 edTPA: Middle Childhood History/Social Studies.
