TEA Updates: Accreditation Status

 Accountability System for **Educator Preparation (ASEP) Annual Report ASEP** accountability indicators are used to determine accreditation status of EPPs. These indicators are described in Texas Education Code (TEC) §21.045 and enacted in rule in Texas Administrative Code (TAC) Chapter 229.



- Statute identifies five measures, which TAC rule further delineates into seven separate indicators:
 - 1a: Certification examination results for pedagogy tests
 - 1b: Certification examination results for content pedagogy tests
 - 2: Principal appraisal of the preparation of firstyear teachers
 - 3: Improvement in student achievement of students taught by beginning teachers
 - 4a: Frequency and duration of field observations
 - 4b: Quality of field supervision
 - 5: Satisfaction of new teachers

- Cohort GPAs Must be a Minimum of 3.0 (Reported to TEA and CAEP)
 - For TEA purposes, all admitted candidates are included in the cohort GPA calculation
 - Undergraduate initial
 - ACP
 - Non-teacher

Year	Number of Admits	Cohort Overall
2020-2021	807	3.28
2021-2022	705	3.37
2022-2023	642	3.33

Notes:

- GPA Waiver was issued during the Spring 2020 semester for Summer and Fall 2020 admits. The waiver was extended to include 2020-2021 and 2021-2022.
- As of Fall 2022, the waiver is no longer in place. The admission GPA is a 2.5 and the cohort GPA will be monitored each semester to ensure the EPP is maintaining a minimum 3.0.





- Cohort GPAs Must be a Minimum of
 - 3.0 (Reported to TEA and CAEP)
 - For CAEP purposes, cohort GPA calculation are separated by initial and advanced.
 - Undergraduate initial and ACP
 - Advanced (Non-teacher)
