# Dr. Stacy Hendricks & Ms. Lisa Stone

- Advising updates
  - o Registration was last week, therefore The Office of Student Services has been advising and getting students ready. The office took over advising students in the EC-6 Online Program.
- Curriculum updates
  - The PCOE Curriculum Committee has been working on reviewing 200 proposals. There should be approximately 75 of those proposals coming to PEC. If there are specific questions contact Stacy Hendricks or Lisa Stone.
    - Faculty submitting proposals in Curriculog indicate if it needs to go to PEC.
    - Educator preparation programs outside the college need to be sure to indicate the proposal applies to educator preparation so PEC will get it. Christina Sinclair added that PEC has proposals to review.
    - PEC curriculum committee members will indicate their vote in Curriculog and should start their reviews.
    - Barbara Qualls asked at what point do you wait or how much of a response from the committee do you need to move forward.

- Fall 2020 and Spring 2021 testing results
  - Conent area 121 students or 66% passed content area
- Spring 2021 CT testing results
  - Content Area 72 students or 30% has passed so far, but we have plenty of time
- Important dates
  - Last Day to be Cleared for Content Exam
    - o December 14<sup>th</sup>
  - Clinical Teacher Orientation
    - December 15th (much earlier than usual, due to holiday falling the way it is as well as the start date for the district for spring)
  - First Day of Clinical Teaching
    - o January 4th or 5th depending on district calendar
- o Registration-Mel
  - OAA Registers Clinical Teachers for AGED 4242, ELED 4242, SEED 4242, and SPED 4242
    - As of 11/19/2020 only students who have holds are not registered for their 6-hour clinical teaching courses
      - o 221 students registered
      - o 20 students with holds
- Christina Sinclair explained that Mel registers students for a genric section so we can move them into
  the specific section they need to be in with their assigned field supervisor who actually ends up being the
  instructor of record.
- SFA EPP and TEA Updates and Information
  - o SFA PEC COVID-19 Waivers
    - PEC issued content test waivers for Fall 2020 and Spring 2021 clinical teachers
    - These candidates must be cleared/approved by their program to take the exam prior to clinical teaching. They do not have to pass the content exam prior to clinical teaching.
    - Fall 2020 clinical teachers will be finished in three (3) weeks
      - 61 clinical teachers have not passed their content test (out of 182)
      - This is 34% of the clinical teachers
    - Spring 2021 clinical teachers begin their clinical teaching assignments in approximately seven
       (7) weeks
      - 169 clinical teachers have not passed their content test (out of 241) 70%
    - Whether to extend the SFA PEC COVID-19 Waiver for testing was discussed and voted on with 22 favor and 1 not in favor.
      - The waiver will stay in place for now.
  - o PEC Issued GPA waiver
    - Fall 2020 and Spring 2021 applicants were issued a waiver to the 2.75 GPA requirement
      - Applicants can be admitted with a 2.50 GPA
      - This relates to all program areas in the EPP
        - Undergraduate Initial
        - ACP
        - Non-Teacher (Professional)
    - The committee discussed whether to extend the PEC Issued GPA waiver and all were in favor of the extension.
    - OAA will provide cohort GPA updates at PEC to monitor changes.
  - o TEA
    - Test approval policy for returning finishers updates
    - TAC 228.40 effective October 15, 2020

- An EPP may require candidates to complete additional coursework to prove preparedness for a certification exam if:
  - O The candidate is seeking test approval in an area where the standards and/or test changed since the candidate completed the EPP; or
  - o If the candidate has returned to the EPP for test approval five or more years following the academic year of completion.
- Test Approval for Returning Finishers
  - o If the EPP does not have a test prep/remediation policy for returning finishers the EPP must give test approval without additional coursework/training/test prep/remediation
- The SFA EPP test preparation/remediation policy: Prior to test approval, finishers must meet with the program coordinator and/or program testing coordinator to determine whether coursework and or training will be required.
- Testing coordinators were sent an email requesting wording for program specific policies (if desired)
- Carrie Baker indicated that if the EPP does not have a policy we have to approve them, as result we developed a policy (see slides) and sent out via email to testing coordinators to see if they have any specific policy for their program and exams to let her know so they can put the information in the handbook. Many have said they like the EPP policy.
- Digital literacy update
  - Christina Sinclair indicated the EPP needs to add a pre-assessment of candidate digital literacy to be in compliane with TEA. Amber Wagnon indicated she would send Christina a pre-assessment that a group of faculty worked on last year.
  - Christina indicated it could become part of the EPP admission process allowing candidates to self-rate before they are in the program and then again towards the end of their program so the EPP can review it.
  - Chrissy Cross added that completing it before clinical teaching could be useful data.
  - Christina Sinclair agreed and will work on getting this in place.

- o CAEP Formative Feedback Report is expected by the end of 11/2020
  - The CAEP Site Visit is 4/18-20/21 and will be virtual
    - A CAEP Site Visit Prep Folder is part of the materials made available to PEC and Christina will continue to add items to the folder and provide additional information at each meeting.

- The committee met October 26th, 2020 and voted unanimously to adopt edTPA as a Unit Assessment to replace the Work Sample.
- Discussion took place about the use of edTPA as a unit assessment.

#### Items from the Floor

- Dean Judy Abbott shared that she would be presenting information to the Nacogdoches ISD School Board.
- The purpose of her presentation to the school board is to share information as a means to change the narrative between the districts and our EPP and find ways to have our partner ISDs think differently about the values we bring to them. She believes our field experiences are mutually beneficial and our clinical practices are mutually beneficial.
- She presented a table that will be transformed into a narrative about the value that we are contributing to the ISD through our EPP.

A case was made that our EPP clinical practice and field experience students contribute additional support in classrooms that adds up to upwards of 1million dollars' worth of manpower.

Dr. Abbott added that she is trying to figure out ways to leverage that information so we can shift the conversation. We can think differently of our assignments and talk differently with partners. She is going to be on the school board agenda to present this data because she wants us to be seen as valuable.
