






#### Required Pass Rates 2018 – 2021

#### **Completion Year 2019**





### COVID-19 Waivers Testing and GPA

- PEC Issued Content Test Waiver
  - Fall 2020 and Spring 2021 candidates were issued a waiver on passing the content test prior to clinical teaching
    - These candidates must instead be cleared/approved by their program to take the exam prior to clinical teaching
- PEC Issued GPA Waiver
  - Fall 2020 and Spring 2021 applicants were issued a waiver to the 2.75 GPA requirement
    - Applicants can be admitted with a 2.50 GPA
    - This relates to all program areas in the EPP
      - Undergraduate Initial
      - ACP
      - Non-Teacher (Professional)



### Content Testing Data Due to COVID-19 Waiver

#### **PEC Issued Content Test Waiver**

- Fall 2020 and Spring 2021 candidates were issued a waiver on passing the content test prior to clinical teaching
  - These candidates must instead be cleared/approved by their program to take the exam prior to clinical teaching
- Fall 2020 clinical teachers will be finished in three
   (3) weeks
  - 61 clinical teachers have not passed their content test (out of 182)
  - 34%
- Spring 2021 clinical teachers begin their clinical teaching assignments in approximately seven (7) weeks
  - 169 clinical teachers have not passed their content test (out of 241)
  - 70%



### COVID-19 Content Testing Waiver Discussion

- Test centers are open with extended hours with social distancing requirements enforced
- Fall 2021 Applications for clinical teaching opens on **December 1, 2020**
- Extend content testing waiver?
- Allow waiver to expire?

Beginning Fall 2021, all candidates will be completing edTPA during the clinical teaching semester + testing (content, STR?)

# GPA Data Due to COVID-19 Waiver

#### PEC Issued GPA Waiver

- Fall 2020 and Spring 2021 applicants were issued a waiver to the 2.75 GPA requirement
  - Applicants can be admitted with a 2.50 GPA
- Cohort GPAs Must be a Minimum of
  - 3.0 (Reported to TEA and CAEP)
    - All admitted candidates are included in the cohort GPA calculation
      - Undergraduate initial
      - ACP
      - Non-teacher

Year	Number of Admits	Cohort Overall	Cohort Last 60 Hours
2019-2020	734	3.24	3.37
Post-Waiver (5/1/2020-10/31/2020	335	3.18	3.29



Note: Out of 335, 45 (13.4%) have been admitted to the EPP with less than a 2.75 GPA. The average GPA of the 45 is a 2.66.



### COVID-19 GPA Waiver Discussion

- Summer/Fall 2021 EPP application opens on March 3, 2021
- Spring 2022 EPP application opens on October6, 2021
- Extend GPA waiver?
- Allow GPA waiver to expire?

Keep in mind, advising for summer/fall begins in January 2021



### **TEA-Test Approval**

Test Approval for Returning Finishers

- TAC 228.40 effective October 15, 2020
  - An EPP may require candidates to complete additional coursework to prove preparedness for a certification exam if:
    - The candidate is seeking test approval in an area where the standards and/or test changed since the candidate completed the EPP; or
    - If the candidate has returned to the EPP for test approval five or more years following the academic year of completion.



### TEA –Test Approval

Test Approval for Returning Finishers

 If the EPP does not have a test prep/remediation policy for returning finishers the EPP must give test approval without additional coursework/training/test prep/remediation



### TEA – Test Approval

 The SFA EPP test preparation/remediation policy: Prior to test approval, finishers must meet with the program coordinator and/or program testing coordinator to determine whether coursework and or training will be required.

 Testing coordinators were sent an email requesting wording for program specific policies (if desired)



### TEA –Digital Literacy Compliance



#### 19 TAC §228.30(c)(8)(A-C)

Curriculum for candidates seeking initial certification in any class must include:

- Instruction in Digital literacy, including a digital literacy evaluation followed by a prescribed digital learning curriculum. The instruction must:
  - Align with the International Society for Technology in Education's standards
  - Provide effective, evidence-based strategies to determine a person's degree of digital literacy; and
  - Include resources to address any deficiencies identified by the digital literacy evaluation.
