FACULTY SENATE

- The minutes of the previous meeting were read, amended and approved.
- II. President Steen explained some items on the University budget and answered questions from Senate members.
- III. After discussion, it was agreed that meetings of the Senate for the Spring Semester would be held at 4:15 p.m. on Wednesdays.
- IV. Vice President Lewis discussed promotion policies at the University. After pointing out the possibility of overcrowding in the upper two ranks (Professor and Associate Professor), he suggested that the Faculty Senate may wish to examine and revise the criterion for promotion.

On the suggestion of Mr. Rodewald, the chairman appointed a committee headed by Mr. Brophy, and including Messrs. Clements and Arscott to study promotion policies.

- V. The committee on amending the constitution made its report. After a brief discussion of some of the problems involved, the subject was tabled until the next meeting of the Senate.
- VI. The results of the faculty ballot on the constitutional amendment that would have given representation on the Faculty Senate to professional librarians was declared invalid since the total returns did not amount to two-thirds of the entire faculty as required by the constitution.
- VII. Mr. Rodewald suggested that the Senate have some say in the selection of the new Director of Libraries. President Steen pointed out that the search for a Director was in the hands of the library committee at present.

The meeting was adjourned.
