- II. <u>Approval of Minutes</u> from Meeting #381. Boatman moved to approve the minutes of Meeting #381. Untiedt seconded the motion and the motion carried.

Announcements from Dr. Berry:

- Congratulations on record high enrollment!
- Discussion on cutting budget of 5%. Setting fees on February 25th will give more insight on our specific situation. Currently looking at conserving energy costs and other spending. Review needs of re-filling vacant positions etc... Broad University consultation will be sought before any plans are solidified.
- Question abt. eliminating low producing programs. Dr. Berry does not feel
 that this would be a savings in cost but this will be looked at for other
 reasons as well.
- Sen. Belanger asks how "painful" as in losing jobs that the cuts may be.
 Dr. Berry answers that that is definitely not expected to take place. What
 will happen with merit raises? Dr. Berry says this will be tied to tuition
 increases and can be subject to reduction. Will protect promotion stipends
 and other prior commitments.
- Sen. Untiedt brings up reductions on photocopies. Suggest .pdf of syllabi and extra readings for courses. Dr. Berry recognizes this as great idea. A mandate on this should be initiated from the Senate. Discussion continues.

 - Can senate address situation of students being dropped from classes due to non-payment? Dr. Berry brings up that these students are supplied with information that those awaiting financial aid need only make a small payment in order to avoid being dropped from classes.
