II. Presentations

A. Dr. Steve Bullard, Provost & VPAA

Dr. Bullard informed the Senate that the Director of the Higher Education Coordinating Board would visit SFA on Oct. 10. The HECB's top priority, as well as the legislature, is the 60 x 30 Texas initiative. The Director will visit the Senate and we will have the opportunity to visit with him.

B. Dr. Marc Guidry, Associate Provost

Dr. Guidry spoke with the Senate his ideas about academics and programs at SFA, and he highlighted some of the initiatives presently in place at SFA, such as beginning a Doctorate in Social Work. He wants to challenge all departments to develop innovative programs and academic programs that are unique in the state.

C. Ron Ivey, Director of Athletics

Mr. Ivey shared with the Senate his vision of athletics at SFA, and most importantly that he and the department were committed to building athletic teams that excel on the field of play as well as in the classroom.
