- I. Faculty Accomplishments
  - College of Science & Mathematics Dr. Michele Harris (Professor, Department of Chemistry and Biochemistry) is the recipient of the first endowed professorship in the College of Sciences and Mathematics
  - College of Fine Arts Dr. Gene Moon (Assistant Professor, music) awarded CFA's second \$125,000 endowed professorship, dedicated to orchestra.
  - Nelson Rusche College of Business **Dr. Susan Jennings** (Professor online B.B.A coordinator) CollegeChoice.net, an independent online publication dedicated to helping students find the right college, has ranked SFA as the sixth best university in Texas to offer an online Bachelor of Business Administration.
  - James I. Perkins College of Education Dr. Chay Runnels, Mary Olle, Todd Barrios, Dr. Gina Causin, SFA Hospitality Administration program was ranked No. 3 on Universities.com best hospitality administration management list.
  - **Dr. Le'Ann Solmonson** (Professor Director of Professional Counseling Program) SFA received the No. 1 ranking from topcounselingschools.org for having the top-value counseling master's degree in Texas. Topcounselingschools.org is an organization committed to helping students find the best higher-education counseling programs.
  - College of Liberal & Applied Arts The **Department of Psychology** is having a banner year in regard to publication. The Department has produced **Ten** publications so far this year.

- Arthur Temple College of Forestry and Agriculture – Hosted 450 high school students in their College Experience event. The event was organized by Erin Brown, Emily Payne, Joey Bray and grad student Courtney Branton.

## II. Financial Forum Report

- One financial item that has remains on the minds of many faculty and was brought up at the forum is the reinstatement of the Summer School pay which was altered 4 years ago. Understanding the upcoming state budget issues, I still felt the necessity to mention it on this report and hope that it can be addressed.

- The Senate will continue to host several Coffee and Social hours throughout the semester to increase faculty participation in Senate activities and receive input from faculty members on any concerns.

#### IV. Post-Tenure Review Concerns
