On 2-26-2024, UPD officers responded to Lumberjack Village in reference to possible illegal activity at a residence in Lumberjack Village. This information was sent anonymously through the SFA University Hotline. Officers arrived and contacted two non-student/males inside a residence. Both subjects were criminally trespassed from all SFA property. One of the subjects was found to have two active arrest warrants through the Nacogdoches Sheriff's Office for FTA-Possession of Marihuana and FTA-Evading Arrest. That subject was arrested and transported to the Nacogdoches County Jail without incident. There are two suspects.

Friday February 23, 2024 – Monday February 26, 2024

On 2-24-2024, a UPD officer contacted an occupied vehicle inside the Lumberjack Village Parking Garage due to the odor of marihuana. The officer contacted the occupants inside the vehicle who admitted to smoking marihuana. A probable cause search was conducted on the vehicle and marihuana was found. One subject claimed ownership of the marihuana and was issued a class b summons for possession of marihuana. There is one suspect.

On 2-25-2024, a UPD officer stopped a vehicle on East College street for a traffic violation. As the officer approached the driver's door the officer smelled marihuana coming from inside the vehicle. The officer could see drug paraphernalia in the center console and the driver admitted to having marihuana inside the vehicle. A probable cause search was conducted where the officer located a handgun, marihuana, drug paraphernalia, and methamphetamine. The driver was arrested for possession of a controlled substance, unlawful carry of a

firearm, possession of marihuana, and possession of drug paraphernalia. The driver was then transported to the Nacogdoches County Jail without incident. There is one suspect.

On 2-13-2024, a UPD officer responded to the University Police Department to meet with a complainant in reference to a theft. The complainant advised that between 12-13-2023 and 2-13-2024 their secured bicycle was taken from the bike rack at Hall 20 without their consent. There are no suspects.

On 2-14-2024, a UPD officer on routine patrol stopped a vehicle for a traffic violation in the 100 block of West College Street. The vehicle was occupied by the driver and one passenger.
