- Oct. 24–27 On 10-25-2025, a UT officer stopped a vehicle in the 3100 block of
 Warwick Lane for a traffic violation. As the officer approached the vehicle the vehicle
 fled the scene. Officers later located the vehicle in the 4800 block of Warwick Lane, the
 engine was still running but the driver had left the scene. This incident is currently
 under investigation. An incident report for evading arrest/detention with a motor vehicle
 has been generated.
- Oct. 23–24 On 10-23-2025, a UT officer was dispatched to the Village Parking Garage to meet with a complainant in reference to a hit and run. The complaint stated that between 10-21-2025 and 10-23-2025 her vehicle was damaged while parked at the Village Parking Garage. There are no suspects.

- Oct. 16–17 On 10/16/2025, a UT officer stopped a vehicle on Raguet Street for a traffic violation. As the officer approached the vehicle they could smell an odor of

marihuana coming from inside of the vehicle. A probable cause search was conducted where the officer found marihuana and THC wax. The occupant of the vehicle was arrested for possession of a controlled substance and possession of marihuana. The occupant was then transported to the Nacogdoches County Jail without incident.

- Oct. 15–16 On 10-15-2025 an officer was dispatched to lot 61 in reference to a hit and run. The complainant stated between 10-14-2025 and 10-15-2025 his vehicle was damaged in lot 61. There are no suspects.
- Oct. 14–15 On 10-14-2025 an officer was dispatched to Steen Hall in reference to a
 drug complaint. The officer located the subject in possession of two possible THC vape
 pens. The vape pens were seized and the suspect was released. There is one suspect.

The suspect was detained and a search of the person revealed they were in possession of a credit card not belonging to the suspect, marihuana, three empty syringes, and one syringe containing a clear liquid believed to be methamphetamine. The suspect was arrested for theft of material copper, possession of controlled substance, possession of marihuana, credit card abuse, and possession of drug paraphernalia. The suspect was then transported to the Nacogdoches County Jail without incident.

 - On 10/7/2025 an officer received information from a social media account of a
 possible sexual assault that occurred on SFA's campus. The officer began an
 investigation and located the victim, who advised on 10-4-2025 she was sexually
 assaulted by a known person at Hall 14. This case is currently under investigation.
 There is one suspect.
 - On 10-8-2025 an officer was dispatched to Lumberjack Village Community Center in reference to theft. The complainant advised on 10-7-2025 his unsecure electric scooter was stolen from the bike rack at Steen library. There are no suspects.
