Executive Administrative Duties and Accomplishments

Fiscal Responsibility and Oversight:

- Currently provide leadership for the following units within the division of Academic Affairs at the University of Northern Colorado:
 - **Faculty Affairs** – *Responsible for all aspects of faculty affairs, including the hiring process, compensation analysis, the tenure and promotion process, sabbatical review and approval, workload review, and conflict/dispute resolution (including Title IX violations). Act as the Provost's designee in all matters related to finance and faculty affairs.*
 - **Academic Resources** – *Responsible for the management and allocation of fiscal, building, and human resources within the division. Manage the budget process for Academic Affairs, reviewing and approving annual budgets for all colleges and administrative units within the division (approximately 140 million). Work with counterparts in Finance and Administration to streamline budget and space utilization.*
 - **Office of Institutional Research and Effectiveness** – *Provide leadership and serve as point of contact for this office. Work with the director of OIRE to prioritize data requests, survey distribution and analysis, and health check dashboards for all areas in the division. This office also works closely with the data team in Information Management and Technology.*
 - **Office of Global Engagement** – *Provide leadership and serve as point of contact for this office. Work directly with the Executive director and other staff members to manage enrollment for international student populations; provide English proficiency supports for students; cultivate and launch study abroad, study away, and exchange programs; and manage the J-1 Visa processes for impacted students.*

- **Extended Campus** – *Provide interim leadership and serve as point of contact for this office. With the recent departure of the executive director, I work closely with the director of business operations and the director of enrollment management to facilitate off campus programming in Loveland, Denver, and online.*
- Previously provided leadership for the following Academic Administrative units in Academic Affairs at Tarleton State University:
 - **Academic Space Utilization** – *this unit was responsible for managing all academic space at multiple campus locations and reporting to the Coordinating Board for the State of Texas. Coordinated academic scheduling of classroom and lab spaces in conjunction with the Registrar and academic departments.*
 - **Institutional Analytics, Effectiveness, and Accreditation (IAEA)** – *this unit provided all academic data and data analysis for the university and campus stakeholders. Refined “just in time” data portfolios (Departmental Profiles) for deans, departments heads, and other academic leaders to assist with operational efficiencies, program planning, fundraising, annual reporting, and accreditation/compliance efforts.*
 - **Registrar** – *this unit provided all services traditionally associated with a university Registrar (Banner System management, catalog and course integration, registration/drop/add support, academic calendar planning, Degree Works scribing, etc.) as well as required Coordinating Board reporting for the State of Texas.*
 - **Strategic Academic Initiatives (SAI)** – *this newly created unit, led by an Assistant Vice president, was responsible for pursuing external funding for academic initiatives, incubating said initiatives, and providing a structure for these initiatives before embedding them within offices in the Division of Academic Affairs. Two examples handed off to others within the division were First Year Experience program (ACE Communities) and TSU’s latest QEP for SACSCOC – Texan Smart.*
 - **Academic and Administrative Assessment** – *this unit coordinated official assessment efforts for campus-wide administrative units as well as required academic assessment. Provided professional development on the use of WEAVE as well as best practices associated with university assessment.*
 - **Administrative Fellowships** – *this newly created unit offered up to two faculty per academic year the opportunity to engage in an administrative fellowship focusing on developing general leadership skills, understanding university and division operations, assisting with special projects within the Division of Academic Affairs.*

- Facilitate the Academic Innovation and Revitalization grant program out of the Provost's Office;
- Work with HR to routinely review the assignment of faculty CIP codes as well as the compensation equity and parity processes for both staff and faculty employees within the division;
- Serve as the division's representative on both the *Salary Equity* and *Welfare* Faculty Senate committees;
- Manage the adjunct, overload, and professional services agreement budgeting process for seven colleges and all other non-academic units within the division;
- Oversee summer instructional budgeting processes for seven academic colleges;
- Provide administrative support for the establishment of our College of Osteopathic Medicine, which is slated to enroll students in Fall 2026;
- Partner with the following AVPs outside of Academic Affairs to improve business functions and the student, staff, and faculty experience: Human Resources, Finance, Administration, and Information Management & Technology;
- Serve as the Academic Affairs liaison for construction planning (most recently the planning for the Osteopathic Medicine building); and
- Serve as a member of our Higher Learning Commission accreditation team (received unconditional continued accreditation as of December 2024)

- Launched the Academic Innovation and Revitalization grant program for faculty and staff, awarding approximately 150-200 thousand dollars in grants each year for innovative practices and/or retooling;
- Streamlined the annual budgeting processes for the division;
- Audited all faculty data in October of 2024 to ensure the accuracy of CIP codes, titles, ranks, and compensation;
- Implemented the department/unit health check process, ensuring that departments/units have accurate data to review on an annual basis rather than relying on 5-year program review processes;
- Automated the sabbatical review/approval process using Faculty Success and improved the annual and comprehensive review processes in Faculty Success;
- Assisted with construction planning for major projects such as the new Osteopathic Medical building and improvements to existing classroom buildings and office spaces for humanities, education, and the sciences;
- Served as a key member of the planning team for the College of Osteopathic Medicine, securing key personnel for the new college and standing up administrative processes within the new college;
- Standardized faculty workload percentages with the division to ensure compliance with UNC's Faculty Workload policy and ensuring the accuracy of load reporting and research expenditures for R2 status;
- Worked closely with the AVP for Enrollment Management to formalize UNC's Strategic Enrollment Management Plan.

- Implemented fiscal responsibility policies and procedures to reduce waste and increase capital reserves year over year in both my former college as dean and within the division as Associate Provost.
