	o Discussion:

- Representative Crenshaw: thrilled that this recognition is in place and believes this should be included in staff council and a standing committee is necessary. Noted we do not want this to take away from the focus of a raise in staff salaries.
- Chair Reed: This is not meant to take away from staff compensation conversations which are still ongoing.

- c. University system affiliation feedback
  - Goal is to solidify the questions that will be sent to each university system for response. Chair recognizes the executive committee for their efforts in filtering and sorting the considerable amount of staff feedback.
  - Chair recognizes the opportunity for feedback from Dr. Westbrook and the Board of Regents as a demonstration of Shared Governance.
  - Dr. Westbrook acknowledged that this is a fast turnaround and request. The
    expectation is for this to be a one-page document. We need to be mindful around
    our expectations of the feedback we will receive. Overly detailed questions are not
    expected to be answered but questions more to the heart of staff concerns are.
  - Review of the proposed questions. Chair Reed read each question to the group.
    - Employee Benefits:
      - Rep. Crenshaw Seeing some things lumped together. Encouraged to separate salary as it is one of the most important topics consistently. Noted that there are other things speaking to Human Resource items, but salary is a constant topic.
      - Rep. Riley questioned lumping leave accrual with salary rather than benefits. Concerns regarding employee transfers from other institutions losing those accruals.
      - Rep. Morton noted that SFA is one of the only schools that gets comp time. Requested highlighting this as well as administrative leave.
    - Organizational Structure:
      - Rep. Crenshaw Request to ask about clerical pools. Will everyone be required to work in a large group? Noted that this may be tied to questions that discuss management changes and alignment with the affiliated school and their structure.
      - Rep. Courtney Beavers I did not get the reduction of force question from what is being presented. Recommend asking if there would be a planned reduction of force – specifically pull this out.
      - Rep. Morton Noted specifically listing the outsourcing question.
         That needs to be pulled out.
      - Proxy for Rep. Herrera outsourcing is a big question in the custodial area because it affects all of us and we hear about outsourcing often. This is a pertinent question that needs to be answered.
      - Rep. Harless for Grounds, the question of outsourcing is a big one as well. Especially if joining the A&M system.

- Rep. Ward regarding salary, because it has already been listed on two different questions, is it important enough to where it could stand alone?
- o Diversity & Inclusion question
  - Rep. Morton questioned whether this question is needed, as many systems are likely more progressive than ours.
  - Rep. C. Beavers noted adding how SFA could improve ours to be better aligned with the system.
  - Rep. V. Beavers support for keeping this question. Noted that there are systems that have not fully developed these initiatives.
- Identity question
  - Rep. Bryant Would like to add a question regarding changes to our visual IP. Athletics has done a lot of rebranding. We have a lot of brand investment.
  - Proxy Rep. Herrera We need to ask if there is a timeline for transitioning to new colors, etc.
  - Rep. Ward Nacogdoches city and county has an identity wrapped around SFA and it would be worth noting this would be a concern for the entire region.
  - Rep. C. Beavers agrees that SFA is an important part of this community and this needs to be noted.
- Capital Campaign question
  - Proxy for V. Herrera: Does this include fundraising efforts from Alumni?
- Database question
  - Rep. Beck asked to remove "academic" databases from this question – as this is not inclusive of all staff databases.
- General Discussion:
  - Rep. Bryant add a question: Would SFA be allowed to remain a Division One member of the Western Athletic Conference?
  - Rep. Jordan has anyone talked with schools who joined a system and discussed these questions with them?
    - Chair Reed yes, we did a presentation on this through the Worklife Committee last year and can share this with our representatives again.
    - Rep. Ward noted that a recording of this presentation is available for the February 28 meeting on the Staff Council website.
  - Rep. Bryant add a question: What would affiliation do to help with recruitment and retention?
  - Rep. Delaney which question fits into whether a Staff Council body will exist or not?
    - Chair Reed we did not narrow to that scope.
  - Rep. Bryant we could be more specific about the groups that stand out from the structure question.
  - Rep. Morton it would benefit us to ask the systems what they gain from taking on SFA.

Rep. C. Beavers – question about the capital campaign, is this asking whether the funds will remain in local banks? This would impact our community lending. Rep. Beck – regarding traditionally underserved, should we add students to that? Rep. V. Beavers – Agreed to include students. Rep. Delaney – regarding the holiday schedule question – could we also add the academic calendar, as this ties to so many departmental procedures. Rep. Crenshaw – add a scholarship deadlines component to the calendar question. This impacts deadlines. Rep. Morton – if you put sub-items under the big question, they can address each one. Rep. Bryant – Add a question: In the event of a campus emergency what resources and response would come from the system? Rep. Coleman – Will the President provide all our questions to the systems, or will the list be edited? • Chair – our understanding is that Dr. Westbrook will provide all the questions, as written. Parliamentarian: clarified that staff questions as well as all representative group questions will be sent. Rep. Riley – clarifying question: Who are the systems interested in us and how serious are they? • Chair listed the four systems and noted that SFA is in formal discussion with each regarding affiliation. Rep. Consford – supports seeing additional line items for individual response on multipart questions. d. Reminders Kickoff workshop – shared date/time, more details coming via email. Request for a time change – Considering moving Staff Council meetings to 10 a.m. o Rep. Riley – PPD employees break from 9:30 to 10. 10 should not be a o Rep. Bryant – it would be very beneficial for my schedule. Chair asked if there were any issues. None shared.
