## CRIME LOG – February 2022

### Friday February 25, 2022 – Monday February 28, 2022

On 2-27-2022 an officer on routine patrol located a suspicious vehicle at the baseball complex on Old Tyler Road. The officer contacted two occupants in the vehicle and found them to be in possession of alcohol. One subject, who was a minor, was issued a citation for minor in possession of alcohol and released. The other subject, who was of age, was arrested for making alcohol available to a minor. That subject was then transported to the Nacogdoches County Jail without incident. There are two suspects.

### Wednesday February 23, 2022 – Thursday February 24, 2022

On 2-23-2022 an officer stopped a vehicle on University Drive for a traffic violation. During the traffic stop the driver confronted the officer which subsequently led to the arrest of the driver. The driver was arrested for evading arrest, reckless driving, resisting arrest, and possession of a controlled substance to wit: methamphetamine. The driver was transported to the Nacogdoches County Jail without incident. There is one suspect.

On 2-23-2022 an officer was dispatched to UPD to meet with a complainant in reference to criminal mischief. The complainant advised that between 2-22-2022 and 2-23-2022 someone damaged her vehicle while parked in Lot 14. There are no suspects.

On 2-23-2022 an officer on routine patrol made contact with a suspicious vehicle that was parked in Lot 42. The officer observed two subjects in the vehicle and made contact. The officer could smell an odor of burnt marijuana coming from inside the vehicle. After a search of the vehicle both marijuana and drug paraphernalia were located. One subject was issued a citation for possession of drug paraphernalia, and the other subject was arrested for possession of marijuana and transported to the Nacogdoches County Jail without incident. There are two suspects.

**Friday February 18, 2022 – Monday February 21, 2022**

On 2-18-2022 an officer was dispatched to Steen Hall in reference to an alcohol complaint. One subject was found to be in possession of alcohol who is a minor. That subject was issued a citation for minor in possession of alcohol. There is one suspect.

On 2-17-2022 an officer was dispatched to UPD to meet with a complainant in reference to an assault. The complainant advised on 2-16-2022 they were assaulted by a known subject at the SFA Coliseum. There is one suspect.

The driver was issued a citation for possession of drug paraphernalia and released. The passenger

was arrested for possession of marijuana and transported to the Nacogdoches County Jail without incident. There are two suspects.

**Friday February 11, 2022 – Monday February 14, 2022**

On 2-11-2022 an officer was dispatched to the lobby of UPD in reference to a hit and Run. The complainant stated on 2-8-2022 her unattended vehicle was damaged in the Lumberjack Village Parking Garage. There are no suspects.

On 2-11-2022 an officer conducted a traffic stop on Griffith Blvd. for a vehicle violation. The officer located the driver in possession of marijuana. The subject was issued a Class B summons to appear before Nacogdoches County Court for possession of marijuana. There is one suspect.

On 2-13-2022 an officer conducted a traffic stop on East College St. for a vehicle violation. The officer located the driver in possession of marijuana. The subject was arrested for possession of marijuana and transported to the Nacogdoches County Jail without incident. There is one suspect.

On 2-13-2022 an officer conducted a traffic stop on North St. for a vehicle violation. The driver was arrested for an outstanding warrant and possession of marijuana. The subject was transported to the Nacogdoches County Jail without incident. There is one suspect.

On 2-6-2022 an officer was dispatched to Lumberjack Landing in reference to an alcohol complaint. The officer contacted one subject who admitted to being a minor and also being in possession of alcohol. One citation was issued for minor in possession of alcohol. There is one suspect.

On 2-4-2022 an officer was dispatched to Lumberjack Landing to meet with a complainant in reference to a sexual assault. The complainant advised in June of 2021 she was sexually assaulted at Lumberjack Village by a known subject. There is one subject of interest involved in this incident.

On 2-1-2022 an officer on routine patrol was advised by two subjects of someone smoking marijuana in the Mize Azalea Garden. On 2-1-2022 an officer stopped a vehicle at the intersection of Austin and Raguet Street for a traffic violation. When the officer contacted the driver, he could smell a strong odor of marijuana coming from inside the vehicle. The driver was later found to be in possession of marijuana. The driver was issued a Class-B Summons for possession of marijuana. There is one suspect.
