On 4-30-2022 an officer was dispatched to Lot 61 in reference to burglary of a vehicle. The officers were eventually able to place both subjects under arrest. One subject was placed under arrest for criminal trespass and resisting arrest, and the second subject was arrested for interference with public duties of peace officer.
